BY-LAW NUMBER 2003-18

**BEING A BY-LAW TO PROHIBIT SMOKING OF TOBACCO
IN MUNICIPAL BUILDINGS**

PURSUANT to Section 115(1), Chapter 25, The Municipal Act, 2001,

WHEREAS the Council of the Corporation of the Township of Bonnechere Valley deems it to be in the best interests of the public to regulate the smoking of tobacco in “municipal buildings” owned by the Corporation of the Township of Bonnechere Valley;

THEREFORE the Council of the Corporation of the Township of Bonnechere Valley ENACTS as follows:

1. DEFINITIONS

- (a) “Smoking” - the use or exposed carrying of a lighted cigar, cigarette, pipe or other smoking device.
- (b) “Municipal Building” - buildings owned by the Township of Bonnechere Valley.

2. LEGISLATION

- (a) No person shall smoke in any portion of any municipal building within the Township of Bonnechere Valley as listed in Section 2(a)(1).

(1) Municipal Buildings affected by this by-law are as follows:

- (a) Museum Building/former Village Centre - 85 Bonnechere St. West
- (b) Cultural Centre (Library) - 74 Maple St. (Seniors) -75 Wallace St.
- (c) Community Centre - 178 Jane Street
- (d) (Former) Fire Hall - 165 John Street
- (e) Municipal Services Building - 49 Bonnechere St. East
(includes: all offices, council chambers, fire hall, ambulance base)
- (f) Works Garage - 145 John Street
- (g) Water Filtration Plant - 401 Water Street
- (h) Sewage Disposal Plant - 131 John Street
- (i) Tourist Information Booth - 46 Bonnechere St. West
- (j) Rotary Beach Park (Beach House/Washrooms) - 178 Jane Street
- (k) Centennial Park (Canteen/Washrooms) - 149 John Street
- (l) Sewage Pumping Station - 131 John Street
- (m) Legion Field (Field House/Washrooms) - Foran/Sommerville St.
- (n) Salt Shed - 145 John Street
- (o) Salt Shed - 33764 Highway #41
- (p) Works Department Bldg. & Garage - 294 Foymount Road
- (q) Works Garage (Foymount) - 112 Janet Road
- (r) Fire Hall (Foymount) - 122 Janet Road

(2) Municipal Buildings and areas thereof not affected by this by-law are as follows:

- (i) Eagles Nest Hall (in the Community Centre)
- (ii) Arena Floor (in the Community Centre) when used for non-recreational purposes
- (iii) Curling Club

3. ENFORCEMENT

- (a) Signs advertising this by-law shall be posted in all Municipal Buildings.

4. PENALTIES

- (a) Any person contravening any section of this by-law is liable to a fine of not less than one hundred (\$100.00) dollars and not more than three hundred (\$300.00) dollars for each subsequent offence, plus costs, recoverable under the Provincial Offences Act.

5. This by-law shall come into force and take effect on the date of its final passing.
