

**THE CORPORATION OF THE
TOWNSHIP OF BONNECHERE VALLEY**

BY-LAW NO. 2003-83

**BEING A BY-LAW TO AMEND SCHEDULES 'A' & 'B' OF
BY-LAW NO. 99-1, BEING THE ROAD NAMING BY-LAW FOR THE
GEOGRAPHIC AREA OF THE (FORMER) TOWNSHIP OF GRATTAN, NOW
IN THE CORPORATION OF THE TOWNSHIP OF BONNECHERE VALLEY**

WHEREAS, Section 48 of the Municipal Act 2001, Chapter 25, authorizes the Councils of local municipalities to pass by-laws giving names to or changing the names of private roads, and for affixing the names at the corners thereof, on public or private property;

AND WHEREAS, Section 11 (1) of the Municipal Act 2001, Chapter 25, authorizes the Councils of local municipalities to pass by-laws respecting matters within the spheres of jurisdiction which includes highways;

AND WHEREAS, it has come to the attention of Council that a private road, (right-of-way) located in the former Township of Grattan was not previously named;

AND WHEREAS, procedures for changing the name of a highway or private road provides that a by-law changing the name of a highway has no effect until a copy of it, certified under the hand of the Clerk and the seal of the Corporation, has been registered in the proper land registry office and before passing a by-law for changing the name of a highway or private road, notice of the proposed by-law shall be given in the manner and at the times that the Council considers adequate to give reasonable notice under the provision of Section 251 of the Municipal Act 2001, Chapter 25.

AND WHEREAS, the Council of the Corporation of the Township of Bonnechere Valley has caused a notice of the proposed by-law to be published in the local newspaper according to the requirements of Section 48, Municipal Act, 2001, Chapter 25, and according to the requirements of Sec. 252(1) & (2), 2003, has heard any person who claims to be adversely affected by the by-law;

NOW THEREFORE, the Council of the Corporation of the Township of Bonnechere Valley enacts as follows:

- 1.) That the following previously unnamed private road in the geographic area of the Township of Grattan (Ward 2) of the new Township of Bonnechere Valley, be added to the Township's civic addressing records: **Sierra Trail**
- 2.) That By-Law No. 99-1 of the Township of Grattan, now the new Township of Bonnechere Valley, is hereby amended to include the private road named Sierra Trail in Schedule 'A' and Schedule 'B'.
- 3.) That save as aforesaid all other provisions of By-Law No. 99-1, as amended, shall remain in force.
- 4.) That this by-law shall come into full force and effect when a copy of said by-law certified under the hand of the Clerk and the seal of the Corporation has been registered in the Land Registry Office.
