BY-LAW NO. 2005-03

**BEING A BY-LAW TO LEVY CHARGES FOR NEW OR REPLACEMENT  
CIVIC ADDRESSING SIGNS**

**WHEREAS** the Municipal Act, S.O. 2001, c.25, s. 116(1) provides that the Council of a Municipality may establish, maintain and operate a centralized communication system for emergency response purposes;

**AND WHEREAS** the Council of the (former) Township of Grattan has passed By-Law No. 98-03, the Council of the (former) Township of Sebastopol has passed By-Law No. 97-17, the Council of the (former) Township of South Altona has passed By-Law No. 98-02 and 98-11, and the Council of the (former) Village of Eganville has passed By-Law No. 98-14, being by-laws to establish a Civic Addressing System;

**AND WHEREAS** the municipality has responsibility for the numbering of buildings and lots along any highway, beach, park, reserve or any other property in the municipality that it is considered necessary to number by the Council, and for affixing numbers to the buildings and for charging the owner or occupant with the expense incidental to the numbering of the lot or property;

**AND WHEREAS** the Municipal Act S.O. 2001, c.25, s. 427(3), provides that the Municipality may recover the costs of doing a thing or matter under subsection (1) from the person directed or required to do it and the municipality may recover the costs by action or by adding the costs to the tax roll and collecting them in the same manner as taxes.

**AND WHEREAS** the Council of the Corporation of the Township of Bonnechere Valley deems it advisable to charge a fee or fees for the installation of new and/or replacement Civic Addressing Signs;

**NOW THEREFORE** the Council of the Corporation of the Township of Bonnechere Valley enacts as follows:

1. THAT the schedule of fees set out in Schedule "A" of this By-Law shall be the fee charged for installation of a new Civic Addressing Sign and the fee charged for a replacement Civic Addressing Sign.
2. THAT By-Law No.2001-78 be hereby rescinded.
3. THAT this By-Law shall come into force and effect on the date of final passing thereof.

READ a first and second time this 24<sup>th</sup> day of January, 2005.

READ a third time and passed this 24<sup>th</sup> day of January, 2005.
